1. The particulars of its organization, functions and duties;

Kumaun University, a residential-cum-affiliating university, came into existence in the year 1973 by notification No. (10)/8651/15/75(85)/64 dated 23 November, 1973 under the Act No. 10 of State Legislature (U.P. State Universities Act, 1973 now adopted by Uttarakhand State) with the merger of two Government Colleges, D.S.B. Government P.G.College, Nainital and Almora Government P.G. College, Almora. These Constituent Colleges were later elevated to the status of University Campuses by Government order No. E-1861/GS dated 14/15 March, 1994.

The University Grants Commission, New Delhi granted recognition to the University under section 12-B of the UGC Act, 1956 and its name appears at serial No. 177. Since then the Kumaun University is receiving central assistance from the UGC. The academic wing of the University is spread over in two campuses (D.S.B. Campus, Nainital and newly constructed Technical Campus at Bhimtal) with an area of 5,31,373 sq.mt. (160 acres), the total built up area being 3,00,000 sq. mt. 21 Government colleges under the administrative control of the State Government, 56 Private institute and 01 Government Aided College, spread over in two districts of Kumaun region are affiliated with the University. It is the biggest State University of the state (Uttarakhand) which caters the need of about 1,00,000 students by providing a high quality educational experience in diverse learning environments and promoting the values and institutions of democracy that prepare students to lead lives of personal integrity and civic responsibility and service to in a global society.

The University is famous for building and promoting a system, which is accessible to people of diverse faiths, races, creeds and cultures and is striving hard for excellence in the creation and dissemination of knowledge, promoting the holistic development of students and preparing them to lead lives of personal integrity, civic responsibility and service to the society. Efforts to galvanize the academic fervor and creative instincts of the youth coming from socially and economically backward areas, to strengthen the interface of academia with the government and industry and prepare the always undertaken. The University is committed to raise the academic standard of all its. two campuses, viz., DSB Campus, Nainital and Sir J C Bose Technical Campus, Bhimtal and 74 affiliated colleges and institutes. For the last three years the University has made untiring efforts to develop some well recognized departments of scientific and social research and these have been attracting faculty members and students from different parts of the country.

Kumaun University became an ideal for all the state universities before the creation of new state of Uttarakhand for regularizing academic session, making education more participatory, creating serious academic atmosphere, generating resources without taxing the students, maintaining strict discipline among students and imposing code of conduct for teachers and this approach is still continuing. Keeping in view its overall achievements the University was accredited with 'A' Grade status in the year 2015 by the National Assessment and Accreditation Council (NAAC). The University has a regular membership of Association of Indian Universities.

In order to cater the technical professional and vocational education, another campus of the University has been developed at Bhimtal. The University is imparting quality education and research facilities in all the eight faculties:

1. Faculty of Arts (Drawing and Painting, Economics, English, Geography, Hindi, History, Home Science, Music, Political Science, Psychology, Sanskrit, Sociology and Tourism)
2. Faculty of Science (Botany, Forestry, Chemistry, Computer Science, Geology. Mathematics, Physics, Statistics, Zoology, Biotechnology, Information Technology and G.I. Science)
3. Faculty of Commerce (B.Com., B.Com.(Hon.), M.Com.)
4. Faculty of Management Studies (BBA, MBA, P.G. Diploma in Tourism, MBA in Tourism, MBA Executive, MBA Rural Management)
5. Faculty of Education (B. Ed. and M. Ed.)
6. Faculty of Law (LL.B. and LL.M.)
7. Faculty of Technology (B. Pharma, and M. Pharma.)
8. Faculty of Visual Arts (B.F.A. and M.F.A.)
9. Faculty of Agriculture, Forestry and Environment (BSc Agriculture, MSc. in Agro Forestry)
10. Faculty of Bio-Medical Sciences (PG level Bio-Medical Courses and Nano Technology)

Various self-finance courses are also being run by the University.

An important collaborative international project “Landscape Asia – Transformation processes, Identity changes and Socio-economic dynamics” which is part of 5ve Asian nations (India, Laos, Nepal, Vietnam and China) has been signed in December 2013 between Department of Geography, Kumaun University, Nainital and University of Paris for the period 2014 to 2017 under the funding support from Ministry of Research, Paris France. Space geology and field geology based investigations are being conducted to monitor ongoing surface deformations in Uttarakhand Himalaya and adjoining Ganga Plain, funded by the DST, Govt. of India and MoST, Govt. of Taiwan, under the prestigious Indo-Taiwan S&T Cooperation programme. Problem of sequential growth of the Ladakh magmatic arc and tectonic evolution of the Shyok Suture Zone of the Nubra valley (northern Ladakh) is being studied in collaboration with Department of Earth and Planetary Sciences, MIT – Massachusetts Institute of Technology, USA and the study of timing of the India-Asia collision and tectonic evolution of pre-syn collision sedimentary basins in Ladakh is underway in collaboration with Department of Geology, Trinity College, Dublin, Ireland. On cave researches for high resolution climatic changes in Central Himalaya research works are being carried out.

physics, biology, materials and engineering and build activities that develop interdisciplinary research and training, University has established a new Centre for Nanoscience and Nanotechnology to advance academic and technological research and development in nanoscience and nanotechnology. International Universities and research institutions like Virginia Commonwealth University, University of Bridgepost, USA, Tindal Consultancy Services (Pvt. Ltd.), Nanyang Technical University, The University of Sydney,

Konkuk University Seoul, Korea are collaborating in this project. The Production and commercialization of graphene for advance nanomaterial based products (Collaboration with Industries) is the ultimate aim of this centre which will not only earn revenue for the University but for the state and country. Research programs in Photodynamic therapy (PDT), Cancer Chemoprevention, Nanotechnology, Pharmacogenomics, Anti-Cancer Pharmaco-nutrition and other fields of Cancer Biology at Kumaun University Nainital are under process.

Resource Development Centre, to the University on 10th of October, 2006 and it started functioning on 12th of February, 2007. The UGC-HRDC, Kumaun University, Nainital shares the vision of making quality the defining element of higher education in India. It has been envisaged that the College will engage not only in its primary task of training of teachers of higher education institutions, but will also undertake varied innovative extension activities in the academic arena. The UGC-HRDC Nainital, the first Human Resource Development Centre in the state of Uttarakhand, is playing a make the HRDC a centre for academic activity that could contribute to the development of this Himalayan region.

As per University Grants Commission guidelines under its XIth Plan the Internal Quality Assurance Cell was constituted by the University on October 30, 2009 with a committee consisting of expert members for guiding and quality enhancement in teaching, research, examination and administrative activities of Kumaun University. Several benchmarks related to quality teaching, research and administrative activities were provided to each unit of the University for Implementation and assessment on annual basis. Performance based appraisal system along with academic performance indicators are being submitted annually by teachers as per UGC regulations 2016, and these regulations are being strictly adhered to for appointments of faculty members.

The Centre has been designed to act as catalyst for promoting and strengthening women's studies through seminars, teaching, research, curriculum, field and extension work, training and continuing education. This Centre is fulfilling the national goals in the field of women empowerment

More and effective use of Information and Communication Technology is being encouraged by the University invariably in all the works. All information related with departments, admissions, rules and regulations of the University, advertisements, recruitments, results etc., are being uploaded and modified on regular basis in the websites by newly established Digital Initiative Cell (DIC). DIC is also being used in improving the quality of learning, curriculum enrichment, professional development of teachers and resource sharing. Some departments have been granted the facility of smart class rooms also.

National Cadet Corps – Army and Naval wings are doing commendable work for the overall development of the students. Recently Cadets of Naval wing of DSB Campus secured first position in four activities at Karwar, Karnataka and for the first time bagged top 10 position. NCC cadets are involved in environmental up gradation, plantation, lake cleaning, campus cleaning and intoxication free society programmes, Digital India Imitative, Yoga, Swach Bharat Abhiyan and several other awareness campaigns. It is for the first time in 2017 both the ANOs of the DSB Campus were awarded commendation certificate from the Chief Minister for their achievement.

NSS Units of both the campuses are actively engaged to render social services in rural, urban and slum areas. Intensive campaign for environmental up-gradation, intoxication-free society, avoiding female feticide, discipline drive among the students, blood and eye donation etc. has been emphasized during the camp hours.

The University has also instituted an independent Chair bearing the name “Mahadevi Verma Peeth”, at Umagarh, Ramgarh in the area of language and literature research, fully funded by the Government of

Uttarakhand. Ministry of Culture, Government of India sanctioned a Grant of Rs. 80 lakhs to Mahadevi Verma Srijan Peeth, Kumaun University for construction of Writer's Home in the name of Amritlal Nagar under Amritlal Nagar Birth Centenary Commemoration and an amount of Rs. 40 lakhs has already being released as first installment thereof.

In the Faculty of Law at S.S.J. Campus, Almora "Free Legal Aid and Counseling Centre" has been established as per the provisions of Bar Council of India. The Centre provides free and fair legal advice to the poor and needy persons. Besides, this, the faculty also ensures its representation in the district level Legal Services Authority. The University Grants Commission has sanctioned a Community College to the University.

University has produced Padama Vibhushan, Padma Shree, FNAs', Scientists, Social Scientists, Writers, Poets, Historians, IAS, IPS, IFS and other Central Services Officers, Armed Forces Officers, Provincial Civil Servants, MPs, MLAs and other renowned Politicians, Businessman, Corporate, Sports persons and many other successful citizens in different walks of life.

Kumaun University aspires to be a bold and dynamic institution, with a "no walls" culture and a spirit of enterprise which strives for positive in ounce and impact through our education, research and service. Every member of our university enjoys diverse opportunities for intellectual, personal and professional growth. We strive to achieve international distinction for creativity, innovation and excellence. All components of the University ensure that it fullfills all of the mandates laid down by the mission and the vision of the university. The university values students, faculty and staff from different backgrounds and faith traditions and is committed to creating an atmosphere of trust, safety and respect in a community characterized by a rich diversity of people and ideas. Recently, Kumaun University has secured 32nd rank in The India Today Group Survey of Indian Universities. The QS BRICS Countries Survey of 9500 universities has also placed Kumaun University at rank 301.

Function, powers and duties of the University- As per the University Act, the University shall have the following functions, powers and duties; namely-

- (1) to provide for instruction in such branches of learning as the University may think fit and to make provision for research and for the advancement and dissemination of knowledge;
- (2) to admit any college to privileges of affiliation or recognition or to enlarge the privilege of any college already affiliated or recognized, as the case may be or to withdraw or curtail any such privilege and to guide and control the work of affiliated and associated colleges;
- (3) to institute degrees, diplomas and other academic distinctions;
- (4) to hold examination for and to grant and confer degrees, diplomas and other academic distinctions to and on persons, who-
 - (a) have pursued a course of study in the University, a constituent college or an affiliated college or associated college or

- (b) have carried on research in the University or in an institution recognised in that behalf by the University or independently, under conditions laid down in the Statutes and the ordinances; or
 - (c) have pursued a course of study by correspondence whether residing within the area of the University or not and have been registered by the University, subject to such conditions as may be laid down in the Statutes and Ordinances as external candidate.
 - (f) are blind and are residing within the area of the University and have carried on studies under conditions laid down in the Statutes and the Ordinances.
- (5) to confer honorary degree or other academic distinction in the manner and under conditions laid down in the Statutes;
 - (6) to grant such diplomas to and to provide such lectures and instructions for persons, not being students of the University, as the University may determine;
 - (7) to co-operate or collaborate with other Universities and authorities in such manner and for such purposes as the University may determine;
 - (8) to institute teaching posts required by the University and to appoint persons to such posts;
 - (9) to recognize teachers for giving instructions in halls;
 - (10) to lay down the conditions of affiliation or recognition of colleges and to satisfy itself by periodical inspection and otherwise that those conditions are satisfied;
 - (11) to institute and award scholarships, fellowships, studentship and prizes in accordance with the Statutes and the Ordinances;
 - (12) to institute and maintain halls and hostels and to recognize places of residence for students of the University, the Institutes or the constituent or associated colleges affiliated;
 - (13) to demand and receive such fees and other charges as may be fixed by the Ordinances;
 - (14) to supervise and control the residence and to regulate the discipline of students of the University, the Institute and the constituent or affiliated or associated colleges and to make arrangements for promoting their health;
 - (15) to create administrative, ministerial and other necessary posts and to make appointments thereto;
 - (16) to do all such acts and things whether incidental to the powers aforesaid or not, as may be requisite in order to further the objects of the University.

2. The powers and duties of its officers and employees;

The Uttar Pradesh State University Act, 1973 adopted by State of Uttarakhand and in exercise of the power conferred by sub section (1) of section 50 of the act University made Kumaun University First Statutes, 1977. In which power and duties of University officers and employees is described the following manner:-

➤ **The Chancellor :**

Section 10(4), 47(c) of University Act and Section 2.01 of Statutes

- (1) The Chancellor may, while considering any matter referred to him under section 68 of University Act call for such documents of information from the University or parties concerned, as he may deem necessary and may, in any other case, call for any documents or information from the University.

- (2) Where the Chancellor calls for any document or information from the University under clause (1). It shall be the duty of the Registrar to insure that such documents or information are promptly supplied to him.
- (3) If in the opinion of the Chancellor the Vice-Chancellor willfully omits or refuses to carry out the Provisions of the Act or abuses the power vested in him and if it appears to the Chancellor that the continuance of the Vice-Chancellor in office is detrimental to the interests of the University, the Chancellor may, after making such enquiry as he deems proper, by order remove the Vice-Chancellor.
- (4) The Chancellor shall have power to suspend the Vice-Chancellor during the pendency or in contemplation of any inquiry referred to in clause (3).

➤ **The Vice-Chancellor :**

Section 13, 49(c) of University Act and Section 2.02 of Statutes

The Vice-Chancellor shall have power to call for such documents and information from an affiliated college in respect of any matter connected with teaching, examination, research, finance or any matter affecting the discipline or efficiency of teaching in the college, as he thinks fit.

Power and duties of the Vice-Chancellor are:-

- (1) He shall be the principal executive and academic officer of the University and shall-
 - (a) exercise general supervision and control over the affairs of the University including the constituent colleges and the Institute maintained by the University and its affiliated and associated colleges;
 - (b) give effect to the decisions of the authorities of the University.
 - (c) in the absence of the Chancellor, preside at meetings of the Court and at any convocation of the University;
 - (d) be responsible for the maintenance of discipline in the University;
 - (e) be responsible for holding and conducting the University examination properly and at due times and for ensuring that the result of such examination are published expeditiously and that the academic session of the University starts and ends on proper dates.
- (2) He shall be an ex officio member and Chairman of the Executive Council, Academic Council and the Finance Committee.
- (3) He shall have the right to speak in and otherwise to take part in the meeting of any other authority or body of the University but shall not by virtue of this sub-section be entitled to vote.
- (4) It shall be the duty of the Vice-Chancellor to ensure the faithful observance of the provisions of University Act, the Statutes and the Ordinances and he shall, without prejudice to the power of the Chancellor possess all such powers as may be necessary in that behalf.
- (5) He shall have the power to convene or cause to be convened meetings of the Executive Council, the Court, the Academic Council and the Finance Committee. Provided that she may delegate this power to any other officer of the University.

- (6) Where any matter (other than the appointment of teacher of the University) is of urgent nature requiring immediate action and the same could not be immediately dealt with by any officer or the authority or other body of the University empowered by or under University act to deal with it, the Vice-Chancellor may take such action as he may deem fit and shall forthwith report the action taken by him to the Chancellor and any of the officers, authority or other body, who or which in the ordinary course would have dealt with the matter.
- (7) Nothing in section (6) shall be deemed to empower the Vce-Chancellor to incur any expenditure not duly authorized and provided for in the budget.
- (8) Where the exercise of the power by the Vice-Chancellor under section (6) involves the appointment of an officer, such appointment shall terminate on appointment being made in the prescribed manner or on the expiration of a period of six month from the date of the order of the Vice- Chancellor, whichever is earlier.
- (9) The Vice-Chancellor shall exercise such other powers as may be laid down by the Statutes and the Ordinances.

➤ **Finance Officer :**

Section 15(7), 49(c) of University Act and Section 2.04 of Statutes

The Finance Officer-

- (a) shall exercise general supervision over the funds of the University.
- (b) may advise it in any financial matter either suo moto or on his advise being sought.
- (c) shall keep a constant watch on the state of the cash and bank balances and on the state or investment.
- (d) shall collect the incomes, disburse the payments and maintain the accounts of the University.
- (e) shall ensure that the Registrar of building, land, furniture and equipments are maintained up-to-date and that stock checking of equipment and other consumable material in conducted regularly in the University.
- (f) shall probe into any unauthorized expenditure and other financial irregularities and suggest to the competent authority, disciplinary action against persons at fault.
- (g) may call for any information or return from any department or unit of the University that he may consider necessary for the performance of his duties.
- (h) shall arrange for the conduct of continuous internal audit of the accounts of the University, and shall pre-audit such bills as may be required in accordance with any standing orders in that behalf.
- (i) shall perform such other functions in respect of financial matters as may be assigned to him by the Executive Council or the Vice-Chancellor.
- (j) shall subject to provisions of the Act and Statutes, exercise disciplinary control in terms of clauses (2) and (3) of Statute 2.06 over all the employees in the Audit and Accounts Section of the University below the rank of the Assistant Registrar (Accounts) and shall supervise the work of the Deputy/Assistant Registrar (Accounts) and the Accounts Officer.

➤ **The Registrar :**

Section 13(9), 16(4), 21(i)(vii), 21(8), 49(c)(e) of University Act and Section 2.06, 2.07,2.08 of Statutes

- (1) Subject to the provision of the Statutes, the registrar shall have disciplinary control over all employees of the University, other than the following namely-
 - (a) Officers of the University;
 - (b) Deputy Registrar and Assistant Registrar;
 - (c) Teacher of the University, whether in relation to their work as teacher or while holding any remunerative office or in any other capacity, such as examiner or invigilator;
 - (d) The Librarian;
 - (e) Employees in the University in the Accounts and Audit Section;
- (2) The power to take disciplinary action under clause (1) shall include the power in order dismissal, reduction in rank, revision, termination or compulsory retirement of any referred to in the said clause and shall employee include the power to suspend such employee during the pendency or in contemplation of an inquiry.
- (3) No order of dismissal removal or reduction in rank shall be made under clause (2) except after an enquiry in which the employee has been informed of the charges against him and given a reasonable opportunity of being heard in respect of those charges.

As per Section 2.08 of Statutes and Subject to the provision in Section 16 of University Act, it shall be the duty of Registrar-

- (a) to be the custodian of all the properties of the University unless otherwise provided for by the Executive Council;
- (b) to issue all notices convening meetings of the various authorized referred to in section 16(4) with the approval of the competent authorized concerned and to keep the minutes of all such meetings;
- (c) to conduct the official correspondence of the court, the Executive Council and the Academic Council;
- (d) to exercise all such powers as may be necessary of expedient for carrying into effect the orders of the Chancellor, Vice-Chancellor or various authorities or bodies of the University of which he acts as secretary;
- (e) to represent the University, in suit or proceedings by or against or University sign powers of attorney and verify pleadings.

➤ **Deputy Registrar :**

State Government sanctioned 02 post of Deputy Registrar for the University and duties described by the state government as per Uttarakhand State (Centralized) Services Rules,2006.

- **Assistant Registrar :**
State Government sanctioned 03 post of Assistant Registrar for the University and duties described by the state government as per Uttarkahand State (Centralized) Services Rules,2006.
- **Controller of Examination :**
The Executive Council of the University approved a honorary post of Controller of Examination (COE) for smooth functioning of the enrolled student's Examination of the University. The duty of the COE is to conduct examination and declaration of the results of the examinee/student of the University.
- **Deputy Controller of Examination :**
The Vice-Chancellor of the University approved honorary post of Deputy Controller of Examination for smooth functioning of the enrolled student's Examination of the University and duties assigned by the Vice- Chancellor and Controller of the Examination.
- **Assistant Controller of Examination :**
The Vice-Chancellor of the University approved honorary post of Deputy Controller of Examination for smooth functioning of the enrolled student's Examination of the University and duties assigned by the Vice- Chancellor and Controller of the Examination.
- **Deans of Faculties :**
Section 18,49(c) of University Act and Section 2.09, 2.11 of Statutes
The Dean of the Faculty shall have the following duties and power-
 - (i) He shall preside at all meeting of Board of Faculty and shall see that the various decisions of the Board are implemented.
 - (ii) He shall be responsible for bringing the financial and other needs of the faculty to the notice of the Vice-Chancellor.
 - (iii) He shall take necessary measures for the proper custody and maintenance of libraries, laboratories and other assets of the departments comprised in the faculty.
 - (iv) He shall have the right to be present and to take any meeting of the Boards of Studies pertaining to his Faculty but shall have no right to vote thereat unless he is member thereof.
- **The Dean of Students Welfare :**
Section 11, 18, 21 (xvii), 49 of University Act and Section 2.09, 2.13,2.16,2.17,2.18 of Statutes
The teacher who is appointed as Dean of student welfare shall perform his duties as Dean in addition to his own duties as teacher.
 - (1) It shall be duty of the Deans of Student Welfare to assist generally the students in matter requiring help and guidance and in particular, to help and advise students and prospective students in-
 - (i) Obtaining admission to University and its courses;
 - (ii) The choice of suitable courses and hobbies;
 - (iii) Finding living accommodation;
 - (iv) Making messing arrangements;

- (v) Obtaining medical advice and assistance;
- (vi) Securing scholarship stipends, part time employment and other pecuniary assistance;
- (vii) Obtaining travel facilities for further studies abroad; and
- (viii) So conducting themselves in power pursuit of academic studies as to maintain the traditions of the University.

- (2) The Dean of the Students Welfare may communicate with the guardian of the student in respect of any matter requiring his assistance when necessary.
- (3) The Dean of Student Welfare shall exercise general control over the Superintendent of Assistant Superintendent or Physical Education if any and the University Medical Officer. He shall perform such other duties as may be assigned to him by the Executive Council or the Vice-Chancellor.
- (4) The Vice-Chancellor may consult the Dean of Students Welfare before taking action against a student as disciplinary grounds.

➤ **Assistant Dean of Students Welfare :**

Section 18,49 of University Act and Section 2.15, 2.13,2.16,2.17,2.18 of Statutes

- (1) The Dean of Students Welfare shall be assisted by a set of teachers, who shall perform their duties in addition to their normal duties of teacher. The teachers so selected shall be called Assistant Deans of Students Welfare.
- (2) One of the Assistant Deans of Students Welfare shall be appointed from amongst the lady teacher of the University, who shall look after the welfare of the girl students.
- (3) The duty of Assistant Deans of Students Welfare shall be same as described for Dean Students Welfare in Section 2.16 of Statutes.

➤ **Heads of the Department :**

Section 49 of University Act and Section 2.20 of Statutes

The senior-most teacher in each department of teaching in the University shall be the Head of Department. The duties of Heads of the Department shall be as per University Act and as assigned by Vice-Chancellor or Executive Council from time to time.

➤ **The Librarian :**

Section 49(c) of University Act and Section 2.24 of Statutes

It shall be the duty of the Librarian to maintain the Library of the University and to organize its services in the manner most conducive to the interest of teaching and research.

➤ **The Proctor :**

Section 18,46(c) of University Act and Section 2.26 of Statutes

The Proctor Shall be appointed from amongst the teacher of the University by the Executive Council on the recommendation of the Vice-Chancellor. The Proctor Shall assist the vice-Chancellor in the exercise of his disciplinary authority in respect of students of the University and shall also exercise such power and perform such duties in respect of discipline as may be assigned to him by the Vice-Chancellor in this behalf.

- **Professor :**
The University Grant Commission Regulations (UGC Regulations) issued from time to time for minimum qualifications for appointment and other service conditions of University for the maintenance of standard in higher education and revision of pay scale.
- **Associate Professor :**
The University Grant Commission Regulations (UGC Regulations) issued from time to time for minimum qualifications for appointment and other service conditions of University for the maintenance of standard in higher education and revision of pay scale.
- **Assistant Professor :**
The University Grant Commission Regulations (UGC Regulations) issued from time to time for minimum qualifications for appointment and other service conditions of University for the maintenance of standard in higher education and revision of pay scale.

3. The procedure followed in the decision making process including channels of supervision and accountability;

The procedure in the decision making process including channels of supervision and accountability is established in the following manner:-

The Executive Council-

- The Deans of Faculties, who shall be members of the Executive Council under section 20(1)(c) of University Act, shall be chosen in the order in which the names of various Faculties are enumerated in Statutes.
- Representation of Professor, Associate Professor and Assistant Professor of the University, who shall be members of the Executive Council under clause (1) of section 20(1)(d) of University Act, shall be chosen as enumerated in Statutes.

- Three Principals and the two other teachers of affiliated College, who shall be member of the Executive Council under sub-clauses (ii) of section 20(1) of the University Act shall be selected by rotation in order of seniority as such Principals and teachers as the case may be.
- Four members from the University Court as Registered Graduate of the University, who shall be member of the Executive Council, shall be selected from University Court through election.
- As per section 21(8) of University Act and section 3.06 of Statutes, the Executive Council may, by resolution passed by a majority of its total membership, delegate such of its powers as it deems fit to an officer or authority of the University subject to such conditions as may specified in the resolution.
- As per section 20, 49(b) of University Act and section 3.08 of Statutes, the Executive Council shall obtain the opinion of the Finance Officer before considering any proposal involving financial implications.

The University Court-

- As per section 22(1) (vii) of University Act and section 4.01 of Statutes two provosts and warden of the hostels and halls of the University and its constituent colleges institutes, if any who shall be member of the Court, shall be selected by rotation on the basis of longest continuous service as such provosts or warden.
- As per section 22(1)(vii) of University Act and section 4.01(1) of Statutes fifteen teachers who shall be members of the Court under (ix) of the section 22(1) of University Act.
- As per section 22(1)(x) and 64(3) and section 4.03 (1)(2) of Statutes two representatives of the Management of affiliated colleges who shall be members of the Court under clause (x) of section 22(1) shall be selected by the Vice-Chancellor by rotation and the management represented shall be free to send to any meeting of the Court any of its members (including President).
- As per section 16(4), 49 of University Act and section 4.04, 4.09, 4.10 of Statutes 15 registered graduate of the University shall be elected as members of the Court.

Academic Council-

- Three Principals of affiliated colleges of the University, who shall be members of the Academic Council under clause (vii) of section 25(2) of University Act shall be selected in order of seniority as Principal of such colleges.
- Fifteen teachers who shall be members of the Academic Council under clause (viii) of section 25(2) of University Act shall be selected as per provisions made in section 5.02 of Statutes.
- Five persons of academic eminence shall be members of Academic Council under clause (xi) of section 25(2) of University Act, shall be co-opted by the members mentioned in clause (i) to (xi) of the section, who shall be called to a meeting by Registrar, from amongst person who are not employees of the University a constituent college, an Institute, an affiliated college, a hall or hostel.
- Subject of the provisions in section 49(b) of the University Act and section 5.05 of the Statutes and the Ordinances, the Academic Council shall have the following powers, namely:-
 - (i) to scrutinize and make its recommendations or proposals submitted by the Board of Studies through the Faculties in regard to the courses of study and to recommend principles and criteria on which examination and the inspections may be appointed, for the consideration of the Executive Council;

- (ii) to report on any matter referred or entrusted to it by the Court or the Executive Council;
- (iii) to advise the Executive Council in regard to the recognition of the diplomas and degrees of the other Universities and institutions and in regard to their equivalence with diplomas and degrees of the University or the Intermediate Examination conducted by the Board of High School and Intermediate Education in the State;
- (iv) to advise the Executive Council in regard to the qualification required to be possessed by person imparting instruction in particular subject for the various degrees and diplomas of University;
- (v) to perform in relation to academic matter all such duties and to do all such acts as may be necessary for the proper carrying out of the provisions of the Act, the Statutes and the Ordinances.

The Finance Committee-

- As per section 26(3), 49(b) of University Act and section 6.02 of Statutes, Items of new expenditure not already included in the financial estimates, shall be referred to the Financial Committee in the cases of -
 - (i) Non-recurring expenditures, if it involves an expenditure of ten thousand Rupees or above;
 - (ii) Recurring expenditure, if it involves an expenditure of ten thousand Rupees or above; Provided that it shall not be permissible or any officer or authority of the University to treat an item which has been split into several parts falling under a budget head as several items of smaller amount and withhold it from the Finance Committee.
- As per section 26(3), 49(a) of University Act and section 6.03 of Statutes, The Finance Committee, shall on or before such date as may be provided for in this behalf by the Ordinance consider all time of expenditure referred to it under Statutes 6.02 or Statutes 6.04 and shall make and communicate to the Executive Council as soon as may be, its recommendations thereon.
- As per section 26(3) of University Act and section 6.04 of Statutes, if the Executive Council, at any time after the consideration of the annual financial estimates (i.e. the budget) proposes any revision thereof involving recurring or non recurring expenditure of the amounts referred to in Statues 6.02, the Executive Council shall refer the proposal to the Finance Committee.
- As per section 26(1), 49(a) of University Act and section 6.05 of Statutes, If the annual accounts and the financial estimates of the University prepared by the Finance Officer shall be laid before the Finance Committee for consideration and there after submitted to the Executive Council for the approval.

The Faculties-

- As per section 27(1) of University Act, The University shall have the Faculties as mentioned in section 7.01 of Statutes.
- As per section 27(3) of University Act, A Board of Faculty shall be constituted for each faculty as mentioned in Statutes.
- Subject to the provisions of the section 27(3) of University Act and section 7.12 of Statutes, the Board of each Faculty shall have the following powers, namely:
 - (i) To make recommendations to the Academic Council regarding the Course of study, after consulting the Board of Studies concerned;

- (ii) To make recommendations to the Academic Council regarding the teaching and research work of the University in the subjects assigned to the Faculty;
- (iii) To consider and make recommendations to the Academic Council on any question, pertaining to its sphere of work which may appear to it necessary and on any matter referred to it by the Academic Council.

The University Disciplinary Committee-

- As per section 49 of University Act and section 8.01 of Statutes, the Executive Council shall constitute for such term as it thinks fit, a Disciplinary Committee in the University which shall consist of the Vice-Chancellor and two other persons nominated by it.
- The functions of the Disciplinary Committee shall be as follows:
 - (a) To decide any appeal preferred by an employee of the University under Statutes.
 - (b) To hold inquiry into cases involving disciplinary action against a teacher or the Librarian of the University.
 - (c) To recommend suspension of any employee referred to in sub-clause (b) pending or in contemplation of inquiry against such employee.
 - (d) To exercise such other powers and perform such other functions as may, from time to time, be entrusted to it by the Executive Council.

The Departmental Committee-

- As per section 49 of University Act and section 8.03 of Statutes, there shall be a Departmental committee in each Department of teaching in the University to assist the Head of the Department.
- The following shall be the functions of the Departmental Committee:-
 - (i) to make recommendations regarding distribution of teaching work among the teacher of the Department;
 - (ii) to make suggestions regarding co-ordination of the research and other activities in the Department;
 - (iii) to make recommendations regarding appointment of staff in the department for which the Head of the Department is the appointing authority;
 - (iv) to consider matters of general and academic interest to the Department.

The Examinations Committee-

- As per section 29 and 49 of University Act and section 8.07 of Statutes, the Examination Committee may, on the recommendation of the person or persons or the sub committee referred to in sub section (3) of section 29 of University Act, debar an examinee from appearing in any futile examination or examinations if in the opinion of the Committee, such examinee was guilty of misbehavior or of using unfair means at any examination conducted by the University.

Research Degree Committee-

- As per section 29 and 49 of University Act and section

The norms set for the discharge of the functions of the University are governed by the U.P. State Universities Act, 1973 now adopted by Uttarakhand State. The norms set by University for the discharge of its functions described in the First Statutes, 1977 of the University. Executive Council, Finance Committee, Academic Council are the bodies of the University to make norms for discharging of University functions from time to time as per University Act and University Statutes. Besides this Government of Uttarakhand, University Grant Commission, NCET and other Regulatory Bodies/Authority of the Central Government makes norms from time to time in different concerning areas for discharging of University functions.
